

Annual Census

The General Laws of Massachusetts mandate an annual street listing (census) of residents as of January 1 of each year. As part of this process we include information that is being maintained in the Commonwealth's Voter Registration Information System. Please update the information provided by adding, deleting, or making changes as needed.

Be sure to return your Census form in a timely manner. Failure to respond to this for 2 consecutive years shall result in removal from the active voting list and may result in removal from the voter registration rolls (see MGL Ch.51 Sec. 4c)

If there is no party information next to your name, you are not a registered voter. If there is a party listed DO NOT change your party affiliation on the census form. Please contact the Town Clerk for more information.

If you did not receive a Census form, please copy, complete and sign the attached form.
